- Tournament fields will be prepared with goals, players' benches, corner flags, and trash cans
- Rental times must include warm-up time as gates will open **30 minutes** prior to requested start time

Tournament Host Requirements

- Tournament host must make 25% non-refundable deposit at the time of reservation to secure venue/fields.
- Tournament host must provide certificate of insurance naming "Orange County Government, PO Box 8181, Hillsborough, NC 27278" as additionally insured at least 10 days in advance of a tournament.
- Tournament host must make rental payment in full 10 days in advance of a tournament.
- Tournament host must submit a final field request layout no later than 10 days in advance of a tournament.
- Tournament host must notify all tournament participants/spectators of all Soccer.com Center rules/regulations.
- Tournament host is required to provide and on-site athletic trainer or equivalent, when requesting 5 or more fields.

Refund Policy

If requested prior to seven days of the reservation date, a full refund less 25% deposit will be given. If requested less than seven days of the reservation no refund will be given. 100% refunds will be given for tournaments cancelled by Orange County DEAPR due to inclement weather and/or unsafe playing conditions.

Orange County is committed to operating its parks and preserves and to conducting its recreation programs and activities in a safe manner and holds the safety of visitors and participants in high regard. Orange County continually strives to reduce associated risks and insists that all visitors and participants follow safety rules and instructions that are designed to protect the visitors' and participants' safety.

In the event that injury or illness is sustained while participating in an activity or utilizing a facility, the undersigned hereby authorizes any emergency First Aid, medication, medical treatment or surgery deemed necessary by licensed medical personnel. The undersigned also gives permission for attending medical personnel to execute on the undersigned's behalf, permission forms if undersigned is not immediately available to do so.

Warning of Risk - Recreational activities/programs/facilities are intended to challenge and engage the physical, mental, and emotional resources of each participant. Despite careful and proper maintenance and preparation, instruction, medical advice, conditioning, and equipment, there is still a risk of serious injury when visiting or participating in any recreational activity, program or facility. Understandably, not all hazards and dangers can be foreseen. Depending on the particular facility or activity, participants must understand that certain risks, dangers, and injuries due to inclement weather, contact with naturally occurring plants or animals, slipping, falling, poor skill level, or conditioning, carelessness, horseplay, un-sportsman-like conduct, inadequate or defective equipment, inadequate supervision, instruction or officiating, and all other circumstances inherent to indoor and outdoor park and recreation activities, programs or facility use exist. Waiver and Release of all Claims and Assumption of Risk- Please read this form carefully and be aware that in signing up and visiting or participating in identified programs, activities or facilities, you will be expressly assuming the risk and legal liability and waiving and releasing all claims for injuries, damages, or loss which you (or member, agent or employee of your group) might sustain as a result of participating in any and all activities connected with and associated with said programs, activities or facility use (including transportation services/vehicle operation, when provided).

I recognize and acknowledge that there are certain risks of physical injury to visitors and participants in these programs, activities and facilities, and I voluntarily agree to assume the full risk of any and all injuries, including death, damages, or loss, regardless of severity, that I, members of my group or our agents may sustain as a result of said participation. I further agree to indemnify, waive and relinquish all claims as a result of visiting or participating in these programs, activities and facilities against Orange County and Sports Endeavors, Inc. including their subsidiaries, officers, officials, agents, volunteers, and employees.

RULES AND REGULATIONS

HOURS: By reservation/permit only. Use of the soccer fields is not authorized without a reservation. Permits may be issued for other activities/sports on a non-priority basis. SOCCER.COM is open for reservations Tuesday, Wednesday, Thursday 5:00 p.m. to 10:00 p.m. and Saturday and Sunday 8:00 a.m. – 10:00 p.m. Friday can be reserved only as part of a Saturday & Sunday tournament rental where the entire facility is reserved.

THE FOLLOWING ACTIVITIES/ITEMS ARE PROHIBITED WITHIN THE PARK:

- Charging admission
- Vending of any sort inside or outside the fence, without a permit
- Banners or advertisements, without a permit
- Bicycles, skateboards, scooters, and inline skates
- Golf Carts
- Pets
- Alcoholic beverages
- Tobacco products
- Firearms or fireworks
- Coolers w/out a SOCCER.COM tag (tournaments only)(Coolers will be searched upon entrance into the facility)
- Mass consumption food (**example: dozens of donuts, pizza's, party trays, etc.**)
- Glass containers
- Painting of any kind on fields without authorization from Soccer.com Center Staff
- Moving goals and player benches without prior approval from gate staff.

WALKING TRACK is for pedestrian traffic or strollers only. Note that soccer balls or players could leave the playing field and possibly collide with track users. Please stay alert and in a position to block children or the frail or elderly. Use of the track is at your own risk.

FIELD CANCELLATION PROCEDURE

If the Orange County Department of Environment, Agriculture, Parks and Recreation (DEAPR) cancel activities due to wet conditions or for other reasons, an announcement will be posted on our weather hot line. You may call (919) 245-2669 for this recorded announcement Monday through Friday after 4:00pm, Saturday and Sunday after 6:00am. Cancellations could be made while you are traveling to the park or even during the game. If DEAPR cancels, or a referee calls the game due to weather conditions, you will receive a credit or refund as long as the game has not begun.
