I am a professor of law at UNC School of Law. I teach in the areas of property law, land use law, and state and local government law.

Volunteer Experience:

I have served on the OC Planning Board (from 2006-2009) but had resigned last year because of additional duties I was facing as Chair of the UNC Faculty Assembly. I'm now nearly one year into those responsibilities with only one year yet to go. I was concerned to see so many of the recent members of the OC Planning Board turn over in December 2008 (a majority of those who've served and worked on the comprehensive plan rotated off or had to resign). I think I could go back on the board this spring and help add some prior experience and expertise to the mix. Some members had suggested that I might be nominated to serve as Planning Board chair when Jay Bryan rotates off. I'd be willing to do that now that I'm nearly half-way through my other University obligations (which will end in spring 2010).

I see that there are two planning board openings... not sure if these are already designated for others. I feel that I have the most knowledge in this area so if need be will stay in the pool for further openings if that's possible. Thanks for your consideration. I'd

like to help with the ongoing efforts to address the proposed UNC airport and other matters facing the county as a whole and Bingham Township (where I live) in particular. I'd also like to assist in the maturation of the newly appointed Planning Board (we had nearly 2/3 turn-over at the end of 2008, in part because some folks couldn't be reappointed due to length of service and in part because several others (including myself) had faced challenges with balancing work and family obligations due to the extraordinary time demands that resulted from recent work on the Comprehensive Plan, major developments (such as Buckhorn Village) and ongoing standard Planning Board responsibilities. I also think this will be a crucial time in helping citizens living in rural Orange to continue to engage effectively with pressing planning issues (particularly in implementing key aspects of the Comprehensive Plan). I think that the County will be well served (and needs) some greater continuity of leadership on the Planning Board particularly given the need to implement the Comprehensive Plan and address pending issues regarding the UNC Airport proposal. I unfortunately had felt obligated to resign (rather than seek another term) when faced with that question early in 2008. Since the immediate work demands that precluded my continuing service had crested at this point, I'd like to volunteer to pick up service again (and several colleagues on the Planning Board have urged me to do so). I appreciate the challenges facing the BOCC in determining how to appoint a good mix of citizens with diverse experience and viewpoints to serve on the Planning Board (as well as other advisory boards), but wanted to let you know that I'd be willing to pick up my service again if you think I could be of assistance.--
