Single Family Units <601 Gallons per day. Less than 2 acres	\$485
Single Family >600 Gallons per day	\$485 + \$105 per 600 GPD or fraction of additional WW flow >600 GPD
Non-Domestic WW (excluding hobby)- Improvement Permit	1.5 X fee for comparably sized domestic WW system
<b>CONSTRUCTION AUTHORIZATION</b>	
Single Family Units <601 Gallons per day.	\$360
Single Family Unit >600 Gallons per day	\$360 + \$225 per 600 GPD or fraction of additional WW flow >600 GPD
Non-Domestic WW (excluding hobby)-Construction Authorization	2 X fee for comparably sized domestic WW system

Well Permit - Bundled with required compliance water sample	\$595

Permit Site Revisit and Revisions (IP, CA, Well)	\$175
Existing System Authorization (requiring a field visit) (ESA)	\$175

26 to 50 spaces	\$240 (Annual)

Scheduled Inspection	\$175
