Note: In Fiscal Year 2005-06 the Streamlined Sales Tax Agreement required a change in the Sales & Use Tax return so that not all taxpayers reported Gross Retail Sales. Beginning with the report for Fiscal Year 2005-06, only Taxable Sales are reported.
