


Animal Control Activities by Jurisdiction



| Assistance: AC assistance provided to other agencies | 109 | 2% |
| Bite: Investigations of bites to humans by dogs, cats, ferrets | 834 | 14% |
| Canvass: AC dissemination of information to the public | 115 | 2% |
| Confiscate: Animal impounds due to legal order violation, cruelty, investigation | 10 | 0% |
| Cruelty: Investigations of animal cruelty | 502 | 8% |
| Exposure: Investigations of animals, people exposed to rabies vector species | 186 | 3% |
| Kennel: Inspections of permitted kennels in Orange County | 54 | 1% |
| Nuisance: Investigations of animals creating a public nuisance | 964 | 16% |
| Other: Activities that do not fall into other categories | 185 | 3% |
| Owned: Activities related to owned animals (e.g. surrenders) | 250 | 4% |
| Protective Custody: Animals impounded due to owners inability to provide care | 6 | 0% |
| Stray: Activities related to stray animals (animals without owners, off property, etc) | 1796 | 30% |
| Tethering: Activities related to a tethered animal | 299 | 5% |
| Trap: Activities related to the trapping of an animal | 316 | 5% |
| Wildlife: Activities related to wildlife species | 447 | 7% |
