

SCHOOL IMMUNIZATIONS

The North Carolina General Statutes (G.S. 130-A-152(a)) require immunizations for every child present in this state. Every parent, guardian or person in loco parentis is responsible for ensuring that their child(ren) receive required immunizations.

DTP/DTAP (5 doses)

Second booster on/ after fourth birthday, before enrolling in K-1 for first time; if a fourth dose of DTP/DTAP was administered on/after the fourth birthday, a fifth dose is not required.

Polio (4 doses)

Booster before enrolling in K-1 for first time
(Note: **Effective October 1, 2005**, the requirement for a fourth dose of polio to be given on or after the fourth birthday has been eliminated); if a third dose of polio was administered on/after the fourth birthday, a fourth dose is not required).

Rubella (1 dose)

One dose on/ after age 12 months

Hib (1 dose)

Vaccine not required if individual passed 5th birthday; number of doses required varies by age (see complete law reference)

Mumps (1 or 2 doses)

One dose on/after age 12 months. Individuals entering school for the first time on or after **July 1, 2008** required to have second mumps vaccine.

Tdap (1 dose)

1 booster dose of Tdap required for those entering 6th grade on or after August 1, 2008 if 5 years or more since last dose of tetanus/diphtheria toxoid.

Hepatitis B (3 doses)

Students born before 7/01/94 are not required to have Hepatitis B vaccine.
3 doses if born on or after 7/01/94.

Measles (2 doses)

One dose on/after age 12 months, second dose at least 28 days later and before enrolling K-1 first time **after 7/1/94**.

Varicella (1 dose)

Students **born on/after 4/01/01** are required to have one dose of varicella vaccine administered on/after 12 months of age.
Students born before 4/01/01 are not required to receive varicella vaccine. (Students affected by this requirement will begin entering kindergarten for the first time during School Year 2006-07)

Rule Changes Affecting School Grade Cohort:

- A** Individual entering school for first time on or after July 1, 2008 required to have second mumps vaccine
- B** Required to have 1 dose of varicella vaccine if born on/after 4/1/01
 *Note: Students born on or after 4/1/01 are required to have 1 dose of varicella vaccine. Students affected will enter kindergarten for the first time in School Year 2006-07.
 **Note: If final dose of hepatitis B vaccine was administered on/after 5/17/02 and was administered before the child was 24 weeks (6 months of age), a repeat dose will be required. Students affected will enter kindergarten for the first time in School Year 2007-08.
- C** Required to have 3 doses of hepatitis B vaccine if born on/after 7/1/94
- D** Booster dose of Tdap required for those entering 6th grade on or after August 1, 2008 if 5 years or more since last dose of tetanus/diphtheria toxoid
- E** Required to have 2 doses of measles vaccine if enrolled in school (K-1) after 7/1/94. Hepatitis B vaccine is not required if born before 7/1/94
- All students** See NC Administrative Code for specific requirements and exceptions: DTaP/DT/Td; Polio; Measles; Mumps; Rubella; Hib; Hepatitis B; Varicella
