- Tournament Facility Requirement**
- Tournament reservations are for the exclusive use of the Soccer.com Center, requiring reservation of all fields for the duration of the tournament. No other user groups will be permitted during tournament reservations.
 - Tournament fields will be prepared with goals, players' benches, corner flags, and lines at Park Manager's discretion.
 - Rental times must include warm-up time as gates will open **30 minutes** prior to requested start time.
 - Restroom facilities are limited, and tournaments may require portable restrooms at the expense of the renter.

- Tournament Host Requirements**
- Tournament host must provide certificate of insurance naming "Orange County Government, PO Box 8181, Hillsborough, NC 27278" as additionally insured at least 10 days in advance of a tournament.
 - Tournament host must submit a final field request layout no later than 10 days in advance of a tournament.
 - Tournament host must notify all tournament participants/spectators of all Soccer.com Center rules/regulations.
 - Tournament host is required to provide an on-site athletic trainer or equivalent.
 - Ice and water for tournament/trainer/team use are not provided on-site. Individual bottles of water are available for purchase at the concession stand.
 - Any additional equipment to support the tournament is at the renter's expense and must receive prior approval and may require additional insurances.

Payment Policy

All tournament organizers are required to make payment in full no later than 10 days following receipt of invoice. Invoices will be emailed to the applicant listed above within 5 business days of the event. Failure to make payment in full will result in forfeiture of any upcoming scheduled reservations. Any future reservations would require prepayment in full.

HOLD HARMLESS AGREEMENT for the SOCCER.COM CENTER**

Orange County is committed to operating its parks and preserves and to conducting its recreation programs and activities in a safe manner and holds the safety of visitors and participants in high regard. Orange County continually strives to reduce associated risks and insists that all visitors and participants follow safety rules and instructions that are designed to protect the visitors' and participants' safety.

In the event that injury or illness is sustained while participating in an activity or utilizing a facility, the undersigned hereby authorizes any emergency First Aid, medication, medical treatment or surgery deemed necessary by licensed medical personnel. The undersigned also gives permission for attending medical personnel to execute on the undersigned's behalf, permission forms if undersigned is not immediately available to do so.

Warning of Risk - Recreational activities/programs/facilities are intended to challenge and engage the physical, mental, and emotional resources of each participant. Despite careful and proper maintenance and preparation, instruction, medical advice, conditioning, and equipment, there is still a risk of serious injury when visiting or participating in any recreational activity, program or facility. Understandably, not all hazards and dangers can be foreseen. Depending on the particular facility or activity, participants must understand that certain risks, dangers, and injuries due to inclement weather, contact with naturally occurring plants or animals, slipping, falling, poor skill level, or conditioning, carelessness, horseplay, un-sportsmanlike conduct, inadequate or defective equipment, inadequate supervision, instruction or officiating, and all other circumstances inherent to indoor and outdoor park and recreation activities, programs or facility use exist. In this regard, it must be recognized that it is impossible for Orange County to guarantee absolute safety.

Waiver and Release of all Claims and Assumption of Risk- Please read this form carefully and be aware that in signing up and visiting or participating in identified programs, activities or facilities, you will be expressly assuming the risk and legal liability and waiving and releasing all claims for injuries, damages, or loss which you (or member, agent or employee of your group) might sustain as a result of participating in any and all activities connected with and associated with said programs, activities or facility use (including transportation services/vehicle operation, when provided).

I recognize and acknowledge that there are certain risks of physical injury to visitors and participants in these programs, activities and facilities, and I voluntarily agree to assume the full risk of any and all injuries, including death, damages, or loss, regardless of severity, that I, members of my group or our agents may sustain as a result of said participation. I further agree to indemnify, waive and relinquish all claims as a result of visiting or participating in these programs, activities and facilities against Orange County and Sports Endeavors, Inc. including their subsidiaries, officers, officials, agents, volunteers, and employees.
