

OCHA's Home Ownership Voucher (HOV) program is accepting applications.

Program eligibility:

- Current HCV recipient
- Complete Homebuyer Readiness Course (list of options on the attached info sheet)
- Have \$2,000 in savings
- Have a full-time job
- Earn at least \$14,500 annually.




To expedite a loss of employment incomes go to: www.orangecountync.gov/housing/participant_information and complete step 1 and 2 as instructed.

Common Questions

Repair Requests:

- For emergency issues (for example a lack of heat/AC/water/hot water, or a hole in roof), please contact both your landlord and OCHA staff at the same time – we will coordinate an immediate solution
- For non-emergency issues (for example suspected mold, a leaky pipe, broken appliances, etc.): contact your landlord (before contacting OCHA) and allow them a reasonable time to respond. If they have not responded after 1-2 weeks and multiple requests, please then contact OCHA staff



Re-certifications:

- HUD requires HCV participants to recertify their income and household composition every year. Please be in touch with OCHA staff, or respond to our calls/emails/letters, even if there are issues.

Moves:

- When moving to another apartment, you must turn in your keys to the old unit BEFORE you sign the lease in the new unit. HUD does not allow housing authorities to pay subsidy on two different units for the same participant, even a few days.
