Orange County is cashless. Operators cannot provide change.



Guidelines for Riding the Bus

All OCPT buses are wheelchair accessible.
 Arrive at the bus stop 5 minutes early. If your stop does not designate a timepoint, use the earlier time.
 Raise your hand to signal you would like to board.
 Tell the operator your destination.

**Never cross in front of the bus, even when stopped.
 Never chase after the bus.**
